United States Attorney General William Barr says the question of whether to continue to indict individuals in connection with the September 11, 2001 terrorist attacks is a decision for the Department of Justice. "The indictment of a terrorist defendant like the 9/11 defendants was not about executing an act of vengeance," said Barr. "It was about holding a defendant accountable for the carnage they caused on 9/11, as well as preventing future acts of terrorism like the ones carried out on 9/11." Following the 9/11 attacks, when the Justice Department led the investigation, the FBI obtained search warrants from federal courts for evidence related to the attacks at the World Trade Center towers, the Pentagon and a plane that crashed in a field near Shanksville, Pennsylvania. In these cases, the office of the chief of the Criminal Division of the Department of Justice charged those who had a role in aiding and abetting the terrorist attacks, including individuals who supported or provided assistance, people who engaged in money-laundering, and others accused of concealing, misapplying and stealing government funds and property. "The indictment, arrest and detention of individuals was an important tool to advance the success of the investigation and prosecution of terrorists. Since the attacks on 9/11, the Department of Justice has applied that same tool against other terrorist defendants around the world," said Attorney General Barr. "The United States will continue to use it to send a message to terrorists that there are consequences to their actions and that we will not allow them to escape justice through funding and other activities that are associated with their terrorist activity," said Barr. "That message will continue to resonate as long as our country faces terrorist threats." Since then, a number of terrorist defendants have been charged in the United States. The Department of Justice has charged more than 100 people, and over 30 defendants have been convicted and sentenced. Additionally, the Department of Justice has sought the indictments of foreign terrorists and countries supporting those who f678ea9f9e
